SINGLE MEMBERSHIP

Open to persons 18 years of age or older who are residents of the United States or Canada. Single members are entitled to one vote and are eligible to hold office in the Association. **Single Member Fee - \$35**

FAMILY/HOUSEHOLD MEMBERSHIP

Open to any two persons of a household 18 years of age or older who are residents of the United States or Canada. Each Family/Household membership is entitled to two votes but only one member may hold office at any one time. **Family/Household Membership Fee - \$50**

JUNIOR MEMBERSHIP

Open to any individual who is under eighteen (18) years of age. Junior members shall not be entitled to vote nor eligible to hold office, but shall be eligible for annual trophies or awards offered by or through the Association. **Junior Membership Fee - \$10**

ASSOCIATE MEMBERSHIP

Open to any person 18 years of age or older who is not a resident of the United States or Canada. An associate member does not have voting privileges and may not hold office or serve on any committee. **Individual Fee - \$35, Family/Household Fee - \$50**

RENEWAL MEMBERSHIP

Members in good standing may renew their membership by completing this form and paying the annual membership renewal fee equal to the fee set forth above for the applicable membership type.

Note: For new members applications received between July 1st and December 31st, dues are one-half the posted price.
